EMERGENCY FOOD DISTRIBUTION - THE MONTANA FOOD BANK NETWORK (MFBN) IS MONTANA'S ONLY STATEWIDE FOOD BANK. WE WORK WITH THE NATIONAL HUNGER-FIGHTING ORGANIZATION, FEEDING AMERICA, AND HAVE DEVELOPED SEVERAL PROGRAMS SPECIFICALLY TO ADDRESS THE UNIQUE CHALLENGES OF ACCESSING FOOD IN MONTANA. WE WORK WITH OVER 280 OTHER HUNGER-FIGHTING PARTNERS THROUGHOUT THE STATE TO IMPROVE FOOD ACCESS AND SHARE INFORMATION TO ADDRESS HUNGER AND ITS ROOT CAUSES.
